MESSAGE FROM THE BOARD PRESIDENT



In 2020, we saw much uncertainty in the state of the world. The coronavirus pandemic brought significant challenges which tested us, and through it we found strength and resilience. We adapted to new ways of working, to carry out our important mission: to ensure the future of Nikkei Place — a unique campus that not only shares the history, heritage and culture of the Nikkei (Japanese Canadian) community through diverse programs, events, and exhibits, but also supports the care of seniors. I would like to acknowledge the incredible dedication of our staff and our donors to Nikkei Place during this time.

During this critical year, the Foundation saw many changes, including new leadership roles and fundraising strategies. In the summer, we sadly mourned the unexpected loss of Robert Banno, Q.C., the Foundation's founding board President. He was a beloved and respected leader in the Japanese Canadian community, and leaves behind a lasting legacy. As the new President, I hope to follow in his footsteps -- to carry on both his legacy and vision for the future, with the help of Paul Kariya as the first Vice-President to our Board.

Staff also adjusted to the temporary departure of Executive Director Naomi Kawarmura, who embarked on a leave of absence to focus on completing her PhD. In her absence, a number of Nikkei Place staff stepped up to help carry the workload until she returns in 2022.

Coming out of a strong financial position last year, the Foundation pivoted to help Nikkei Seniors Health Care & Housing Society (NSHCHS) and Nikkei National Museum & Cultural Centre (NNMCC) with fundraising initiatives, as lockdowns and gathering limitations affected all major fundraising events, gatherings, and programs. For the first time, we launched a number of online giving campaigns, and found success as more supporters than ever were willing to give online. At a time when physical distancing was the new normal, our donors were instrumental with keeping the doors of Nikkei Place open, and the feeling of community and camaraderie alive.

One of the positives this year is the continued growth of the Nikkei Place Legacy Endowment Fund, thanks to the generosity of Dan Uyesugi, Cathy Makihara, and planned gifts from the late LA Dinsmore and Tamiko Corbett.

This year we have learned a great deal, and look ahead with eyes wide open, and a renewed sense of optimism for the future. We will continue to build a strong financial future that supports our vibrant Nikkei Place community. Thank you to all our supporters, donors and charitable partners for their continued support.





CHANGE & **RESILIENCE**

REMOTE WORK

2020 has been a challenging and transforming year. In response to the COVID-19 virus, the Foundation's staff adapted to new ways to work remotely, we shifted our calendar of activities, and we cancelled our annual fundraising gala. However, the Foundation was fortunate to have the continued kindness, support and generosity of our donors. We found more donors than ever gave online in support of Nikkei Place charities.

CHANGING LEADERSHIP

2020 marked the passing of Robert Banno, Q.C., the founding President of the Nikkei Place Foundation. Robert was instrumental in the Foundation's growth and current success. The Foundation and the Japanese Canadian community will miss his strong leadership, his kindness and generous spirit and heart. Brian Tsuji was appointed the new President of the Board, with Paul Kariya also stepping into a new role as Vice-President.

This year, the Foundation also saw the temporary departure of our Executive Director Naomi Kawamura, who began a leave of absence to concentrate on her PHD studies at UBC. Naomi has been Executive Director of the Foundation since 2017, and we look forward to her eventual return to the team.

FUNDRAISING ONLINE

The Foundation helped Nikkei Seniors Health Care & Housing Society (NSHCHS) and Nikkei National Museum & Cultural Centre (NNMCC) with fundraising initiatives, as lockdowns and gathering limitations affected all major fundraising events, gatherings, and programs.

Resilience Fundraiser (April 2020 - January 2021)

The pandemic forced Nikkei Centre to close its doors, and find new ways to provide programming online. The Resilience Fundraiser was launched to help raise essentail operational funds for the NNMCC.

Beat the Odds Campaign (April 2020)

Donors came together in lieu of participating in the Nikkei Place Charity Golf Tournament & Fundraiser with the Beat the Odds Campaign. The campaign supported NSHCHS' dementia-friendly and outreach programs for 2021.

Great Canadian Giving Challenge (June 2020)

The Foundation participated in CanadaHelps' Great Canadian Giving Challenge — a contest where every dollar donated online during the month of June was a chance for our charity to win the grand prize of \$20,000.

• Giving Tuesday (May/November 2020)

The Foundation participated in Giving Tuesday, a global movement to encourage charitable giving. Donors came together to raise \$6,500 in a single day for Nikkei Place charities!

INSPIRE ACTION Campaign (March 2021)

The NPF and NSHCHS launched the INSPIRE ACTION spring fundraising campaign, in lieu of the Nikkei Place Charity Golf Tournament, with the "Tub, Tech, Reboot" call to action. The campaign supports a spa tub replacement and virtual outreach programming for seniors in 2022.


